### Scope

*Lithuanian Historical Studies (LHS)* is an academic peer-reviewed English-language periodical journal, published annually by the Lithuanian Institute of History. Its aim is to progress and disseminate historical research on Central and Eastern Europe, with special focus on Lithuania and the neighbouring states. Even though most of the published studies cover political, social, religious, economic and cultural topics, yet the journal welcomes submission of innovative and multidisciplinary research. Besides the scientific articles, the *LHS* also publishes new or little-known source material, book reviews and notices, abstracts of the defended dissertations in history in Lithuania, and other relevant material. All submissions undergo a rigorous peer review process, based on double-blind refereeing by a minimum of two specialist referees. The accepted articles that were submitted in Lithuanian are translated into English at the journal's expense.

## **Open Access**

*Lithuanian Historical Studies* is a fully Open Access journal, which means that all content will be freely accessible online. All articles will be published under a non-exclusive Open Access license. No article processing charges or submission charges are applicable. The author keeps full copyright and gives Brill permission to publish by signing a special Brill Open Consent to Publish form. ### Instructions for Authors

#### Double-Blind Peer Review

Every article that conforms to the formal instructions (see: *Submission Requirements*) undergoes doubleblind peer review. This can take up to three months. In case of delay or other *force majeure*, the Editors will immediately inform the corresponding author about the delay.

#### Deadline

The final date for submission for the ongoing year's issue is **April 1**. However, in case of thematic or other specialised issues, publication of individually submitted texts might be postponed. The Editors will immediately inform the submitter about the delay. ### **Submission Requirements**

#### Language

*LHS* publishes articles in English. Contributions should be grammatically correct and in good literary style. All spelling should be consistent. Accepted articles that were submitted in Lithuanian are translated into English at the journal's expense.

#### Font

It is recommended to use Times New Roman or similar fonts. For extended characters, authors should ensure that they use a Unicode friendly font such as the Brill (<u>brill.com/about/brill-fonts</u>).

#### Unicode and Non-Roman Fonts

The Editors request the use of Unicode fonts only.

References should be in Latin or Cyrillic scripts. In case of using other alphabets, please contact the Editors.

If you have any questions about other languages, fonts or any other related issue, please contact the editors.

#### Length

Articles should be between 7,000 and 11,000 words in length, including: references; bibliography; annotation (up to 200 words), five keywords and a summary (up to 500 words). In case the summary is written in English, it will be translated into Lithuanian at the journal's expense. Reviews should comprise between 1,000 and 2,000 words.

## **Manuscript Structure**

#### Abstract and Keywords

All manuscripts should be accompanied by an abstract in English of no more than 200 words and a list of five keywords.

#### References and Bibliography

#### General Instructions

Literature citations in the text should be given in the footnotes.

All cited material should also be given at the end of the article in alphabetic order in the bibliography. Publications in scripts other than Latin (i.e. Cyrillic) are placed at the end and organised alphabetically.

#### Journal Article

Journal articles often list many authors, especially in the sciences. If there are four or more authors, list up to ten in the bibliography.

For more than ten authors (not shown here), list the first seven in the bibliography, followed by *et al*. In the footnote, list only the first author, followed by *et al*. ("and others").
